## **PAST EVENTS**

 $12.05 \rightarrow BAMI's$  Board held a face-to-face and online meeting, at which a decision was made regarding the Association's annual General Assembly, its agenda was discussed and relevant documents adopted. Information and materials are published on the website of the Association. The Board discussed the submitted request for joining the Association and adopted the company "Harmony 2012" JSC as a member of BAMI by an absolute majority.



**18,19 и 27.05** — Implementing the project of Bulgarian Industrial Asociation for promotion of longer working life and management of generational differences ("Active aging"), three online working meetings were held with the participation of BIA, BAMI and representatives of Alcomet, Stomana Industry and Promet Steel respectively. Draft company programs for the implementation of policies in these areas and for the implementation of the tools prepared during the project were adopted.

 $28.05 \rightarrow BAMI$  took part in a discussion forum organized by CITUB on the challenges and possible solutions for fair transition of high-risk coal-mining regions and their place in the territorial development plans. Deputy Ministers from MLSP, ME and MI also took part in the event. A separate panel discussed the technological transformation of industrial sectors, including metallurgy. The participants were acquainted with the investments and technological changes in the metallurgical production.

 $31.05 \rightarrow$  At an extended online meeting of the Tripartite Council on Working Conditions "Metallurgy" at the Ministry of Economy, a **draft Ordinance on ensuring healthy and safe working conditions in ferrous and non-ferrous metallurgy** was discussed. The draft text was prepared with the participation of H&S experts from companies, UCTM, trade unions and BAMI. After the inclusion of the comments made, the revised version will be presented to the MLSP and the sectora companies for new discussion and final adoption.

13.05 → In connection with the expected package "Fit for 55" and the revision of the European Emissions Trading Scheme (ETS), BAMI sent a letter and a document to the Ministry of Economy, Ministry of Environment and Water and all Bulgarian MEPs. They were prepared by the Alliance of Energy Intensive industry (AEII) and in them the European energy-intensive industries state their recommendations on these issues and insist on preserving industry competitiveness in the process of achieving the goals set; insist that the "Fit for 55" package be effective but also balanced; taking into account the importance of industry for the European economy.
