In this regard, in a joint letter to the Prime Minister, the social partners in the metallurgical sector insist on quick and effective actions by the state. August → Morocco has launched a review of a safeguard measure on imports of wire rod and certain types of hotrolled iron or non-alloy steel bars into the country. The measure affects goods with tariff codes: 7213 91 90 - wire rod; 7214 20 90 to 7214 99 91 - steel bars. Interested parties may register as such and request from the Moroccan investigating authorities to complete questionnaires by 7 September 2021.
